Professional Cabin Fever? Join a Chapter Committee!

Are you feeling a sense of frustration in the workplace because fiscal constraints are preventing you from doing what you view as essential work? Have you experienced episodes of professional tunnel vision as a consequence of decreased opportunities for interactions with the full diversity of fisheries professionals beyond your immediate workstation? Have you been self-medicating after hours with questionable television?

If you have experienced any of the above symptoms then you might be suffering from professional cabin fever. In the final stages, victims rarely leave their cubicles and, when they do, their co-workers mistake them for visiting retirees. The progression from inspired and idealistic young fisheries professional to malaise-stricken cube hermit is slow and painful but the good news is that there is a simple cure: find an AFS Chapter Committee that is working on something that piques your professional interest and join it!

Even if circumstances severely restrict your ability to travel, there are many committee tasks that can be distributed electronically, accomplished at your own desk, and yet still afford an increased sense of connection with other fisheries professionals and relieve those nagging perceptions of isolation and confinement.

Biography of Ed Woltmann

Ed Woltmann has spent the past 25 years as an employee of the New York State Department of Environmental Conservation (DEC) Bureau of Fisheries, most recently serving as a Supervising Aquatic Biologist overseeing the Bureau's Public Use and Outreach Section. Ed began his career as a biologist in 1984 researching the use of sterile grass carp as aquatic vegetation control agents in New York State which led to the current DEC permit program for use of the fish in New York. Following his efforts with sterile grass carp, he has served in various capacities with DEC including 10 years as a Regional Fisheries Manager on Long Island and as both Warmwater and Coldwater Unit Leader in DEC Central Office. Ed is particularly proud of the efforts he and staff put forth to improve fishing and increase fishing participation on Long Island, as well as the successful introduction of walleye in Lake Ronkonkoma and Fort Pond to control overabundant white perch communities in both waters. Ed grew up on Long Island and currently resides in Averill Park, NY with his wife Lori and son Daniel. He graduated from the University of Vermont with a BS in Wildlife Biology. His professional interests include warmwater fisheries management, youth education and fisheries outreach. On the personal side, he enjoys hunting and fishing and both playing and coaching ice hockey.

Ed has been very active in Chapter activities and is best known for his role as the General Chair responsible for the organization and implementation of the 2006 Annual Meeting of the American Fisheries Society held in Lake Placid New York. This successful meeting remains the most well attended AFS meeting ever held in the Northeast and continues to bring fond memories to all that attended. He served as Program Chair for the 1995 Chapter Meeting in Owego and also served in the same capacity for the 2001 Northeast Fish and Wildlife Conference. A long-term member of the New York Chapter who has noted the significant variation in membership and meeting attendance, Ed promises to work hard to find creative ways to encourage all involved in the world of fisheries in New York to participate in the New York Chapter and attend the annual meeting.

Workshop

Fish Identification Workshop- On February 10, 2010 a workshop focused on the identification methodology of the fishes of NY was conducted at Fort William Henry as part of the NY Chapter of the American Fisheries Society annual meeting. Dr. Robert Daniels, Dr Rick Morse, and Brian Weatherwax from the New York State Museum instructed 33 fisheries professionals and students from throughout the state on the topic of fish identification. Of these 33 attendees, 22 were DEC employees. This workshop was coordinated and subsidized through the New York Chapter of the American Fisheries Society.

This year's workshop focused on the Catostomidae, Cyprinidae, and Percidae of NY as these families include most of the harder to identify species. Preserved and live specimens were available for attendees as well as a Museum developed dichotomous key. Introductory presentations were provided by Lisa Holst and Doug Carlson on the importance of proper identification, vouchering specimen, the utility of preserved collections, and the resources available for fish identification. Workshop evaluation revealed that attendees found the workshop worthwhile.

About the Instructor: Dr. James B. (Jim) Reynolds is Professor Emeritus of Fisheries at the University of Alaska Fairbanks where he served on the faculty during 1978-1999. Jim is a recognized authority on electrofishing and ecology of northern fishes. He has taught electrofishing short courses to over 1,500 biologists in the U.S. and Canada, is the author of the chapter on electrofishing in "Fisheries Techniques" published by the American Fisheries Society and has written numerous research articles on the subject. Jim is Past President of the Education and Fisheries History sections and Missouri and Alaska chapters of the American Fisheries Society. He also provided technical guidance for the NOAA Fisheries electrofishing guidelines (see link above). Other instructors will assist during the field portion of the class.

Intended Audience: This course is intended for biologist, field personnel, and other professionals seeking an improved understanding of the principles and techniques of electrofishing.

What to Bring: All participants must bring a notebook, pen/pencil, electronic calculator, and bottle of water. Please also bring insulated rubber gloves and knee boots or hip waders and dress for prevailing weather during the field trip. You are also encouraged to bring your own boat electrofishing unit if you have access to one. You will gain knowledge of the specific optimal settings for your unit and hands-on experience using it in the field. There will be boat electrofishing equipment available for those who do not bring their own.

Permanent Rock Ramp Fishway Installed in the Peconic River

For over a decade, the Peconic Estuary Program and NYSDEC have been working relentlessly with federal, state, and local agencies and non-profits to install a rock ramp at the Grangebel Park South Spillway on the main stem of the Peconic River; the headwaters of the Peconic Estuary. After 10 years of project planning, permitting, and contracting delays, the much anticipated rock ramp is in!

The first phase of the project, extensive repairs to the structural integrity of the Grangebel Park North Spillway, was completed in late December 2009. The second phase of the project, the South Spillway rock ramp, commenced shortly thereafter and was completed in early February 2010; just in time for the spring migration. This new fishway will allow permanent access to 24 acres and 1.5 miles of prime, critical habitat and spawning grounds in the Peconic River, and will provide an impetus for additional fish passage restoration projects upriver.

The rock ramp replaces an Alaskan steep pass ladder which was installed every spring since 2000 in Grangebel Park's North Spillway. The steep pass was very costly to maintain and remove seasonally, was not suitable to pass American eels, and was a safety hazard. A more natural looking and functioning rock ramp in the South Spillway creates permanent alewife and American eel resting pools to allow unimpeded access.

Project design, planning, and construction was supported by numerous entities including: USFWS, NOAA, NYSDEC, NYSDOS, Suffolk County, Town of Riverhead, FishAmerica Foundation, American River, NY- Corporate Wetlands Restoration Partnership, Spectra Energy, and National Grid.

The Committee for Conservation of Native Fish Diversity has been helping with an early step in reclassifying NY's inland fishes as endangered or threatened, in a process called a field trial. The earliest of the committee's activities began in May 2006 with one of its key purposes to help assemble information about these fishes and with this reclassifying process. The field trial began in January 2010 as a test of the assembled information on eight fishes and the capabilities of an expert panel. After 3 months of deliberation, evaluations have been completed by nine members or volunteers. The simplified classification process was intended to draw a boundary between those fish that are at-risk, or likely to become extirpated in the long term or short term, and those that are not. Three fish were judged to be above the boundary, summer sucker, mooneye and comely shiner, and they were classified as "at-risk". The other species included longnose sucker, blackchin shiner, channel darter, eastern sand darter and satinfin shiner. When the full-scale classifying process is engaged sometime in the coming year or the next year, the volunteer experts will classify a larger group of fish and will meet as a panel to deliberate on those species where agreement was most lacking. This field trial was very helpful in identifying the quality of the assembled materials and the scale of the task at hand. (submitted by D. Carlson, March 2010).

ANNUAL BUSINESS MEETING MINUTES
NEW YORK CHAPTER OF THE AMERICAN FISHERIES SOCIETY
FEBRUARY 4, 2009
TREADWAY INN, OWEGO, NY

President Fred Henson opened the meeting with a few short announcements:

- President Henson began by requesting a quorum, Secretary Jones stated that a quorum had been reached.
- President Henson thanked the Executive Committee for their effort, both as a group and individuals.
- Meeting Minutes from 2008 were presented, a motion was made by Margaret Murphy, 2nd by Greg Kozlowski, motion passed unanimously.
- Mike Flaherty discussed the nexus of the bylaw revisions as changes to the “Society” bylaws that needed to be carried down as well as other changes requested by the membership. Alan Peterson moved to accept and approve the amended bylaws as written with the understanding that the language required approval of the Governing Board. The motion was seconded by Doug Sheppard and was approved unanimously (32 for, 0 opposed).
- Randy Jackson discussed the raffle ticket sales and the format for the 2009 raffle.
- President Henson reminded members to cast their vote for president.

Old Business

- Credit Card Machine – Secretary/Treasurer Jones discussed the merits of the Credit Card Machine and how it has made the Treasurers duties much easier. He recommends that we continue on with the rental agreement and he will continue to analyze the costs of renting/versus purchasing.

Treasurer's Report

Treasurer Jones presented the 2008 Annual Treasurers Report. The NYC continues to report to the Internal Revenue Service. Interest on Certificate of Deposits (CD) has tapered off during 2009. Balance of the checking account is significantly higher than normal; however methods for reducing this amount are being solicited. Auditor Arrigo conducted an audit of the 2008 books – everything was in order.

A meeting is schedule for student interaction, conversation and questions. A facebook page will be set up to encourage additional student interaction.

Professional Diversity - No Chair – No report. Committee has been dissolved.

Youth Aquatic Education - *Tom Hughes* – Designated as new chair of this committee.

Native American Affairs: - Dawn Dittman –Dawn has established contacts with the appropriate tribal liaisons. However, additional activity has occurred.

Resolutions/Environmental Concerns: R. Vaas –No report

Workshop: Chris VanMaaren – Chris presented a progress report on the Genetics workshop held on February 3rd. The workshop was a relative success and was widely attended both locally and remotely. Chris anticipates a Fish id workshop for 2009. This workshop is based on a workshop that has been designed by Bob Daniels.

Nominating: Emily Zollweg - Nominations for President Elect for 2009 include Matt Sanderson and Mark Malchoff.

Professional Incentives: - Sarah Zappala – The Honorary Member Award, the Professional Achievement Award, and the Conservationist of the Year Award continue to be offered. Sarah was not present but reminded everyone via an email report of what should be included in a nomination for any of these awards.

The 2nd Dave Bryson Memorial Scholarship Award will be also awarded at the banquet dinner. The Executive Committee has received nominations for this award. The selected recipient is Ross Abbett a Masters Student at SUNY Brockport who has been involved and is interested in fisheries issues.

Audit/Finance: M. Arrigo - Mark reviewed the books; they appeared to be in order. Following this audit, mark has resigned as Chair citing professional and personal responsibilities. President Henson will search for a new chair for this committee.

Native Fishes – Jim McKenna – Discussions continue on how to revise the standards for native fishes. Group meetings/discussions occur annually in conjunction with the Annual Meeting.

Changing of the Guard

- Result of the election determined that Matt Sanderson has been voted in as the president elect.
- Randy Jackson was escorted to the podium by Past Presidents Margaret Murphy and Emily Zollweg. Randy was sworn in as the 2009 president.
- President Elect Randy Jackson presented Fred Henson with the President's Appreciation Plaque.
- President Jackson presented the 2009 budget proposal. Fred Henson moved to accept the budget, Scott Jones 2nd, passed unanimously, budget approved.
- President Jackson introduced a potential theme and location for 2009 that will be focused on our historic fisheries resources, more details will be provided as this topic develops during 2009.

New Business

Fred Henson put forth a proposal in an attempt to decrease the discretionary surplus of the Chapter based on a requirement of our officer's handbook. This proposal includes an approach to bring our Chapter finances to appropriate levels over a 5-year period. Margaret Murphy proposed a few language changes to Fred's proposal and motioned to accept this plan as amended; the motion was seconded by Casey Festa and passed unanimously. The motion is detailed below. The details were provided as part of a slide presentation at the meeting.

The NYCAFS shall apply in 2009, on a one year trial basis, the spending guidelines recommended by EXCOM (my five year proposal that I faxed to you) and approved by the membership on February 5, 2009. EXCOM is therefore authorized to spend up to \$2,242 beyond a balanced operating budget. EXCOM shall report to the membership on the disposition of the above funds at the 2010 business meeting.

Fred Henson made a motion to adjourn the Annual Business Meeting, Doug Sheppard 2nd, passed unanimously and meeting adjourned.

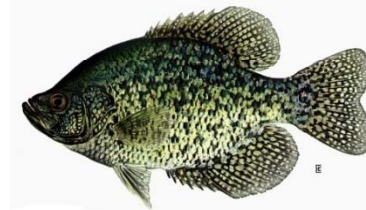
